
WHEREAS the Court finds that the fees and expenses set forth in said Application are reasonable; and

The Receiver's First Interim Fee Application is hereby approved in the amount of \$173,839.69 and, the Court further specifically approves the allocation for payment of said fees for this Application as follows: the sum of \$130,379.77 from the Receiver's FarmGrowCap account and the balance of \$43,459.92 from funds held within the Receivership Private Placement Bank accounts, namely: Blue Crop Group (\$16,565.49), True Blue Berry Management (\$10,012.14), Jennings Design (\$8,458.38), and HF Land GP (\$8,423.92)
