ORDER TO SHOW CAUSE

On June 23, 2015, the Court entered an order setting this matter for a settlement conference on January 15, 2016. [Dkt. 66 at 1.] In relevant part, the Court’s order provides:


The parties are instructed to jointly prepare and submit (not file) a draft settlement agreement, noting any disagreements by the parties. The agreement in question should represent, to the extent possible in the circumstances, the final written agreement intended by the parties to resolve the case and should contain all material provisions that any party believes should be contained within such document, such that the settlement agreement proposed can be executed in full and final settlement

of the matter at the successful conclusion of the settlement conference. **The draft settlement agreement shall be emailed to the Magistrate Judge in Word format at MJDinsmore@insd.uscourts.gov no later than five (5) business days before the settlement conference.**

[*Id.* 5 (emphasis in original).] The parties' draft settlement agreement was thus due by no later than January 8, 2016.

The parties did not submit their draft settlement agreement before the January 8, 2016 deadline, and have not to date submitted the agreement. The parties shall have until **Wednesday, January 13, 2016** to submit their draft settlement agreement to the Court or until **11:00 a.m. on Thursday, January 14, 2016** to show cause why they should not be sanctioned for failure to comply with the Court's order.
