Additionally, sealing the aforementioned exhibits will not impede the public's right to access as Receiver's counsel is contemporaneous to the filing of this Motion to Seal, filing an Amended Declaration of Jarit Loughmiller along with redacted versions of exhibits that remove any identifying information.

4. Pursuant to S.D. IND. L.R. 5.11, Receiver, by counsel, requests that the Declaration of Jarit Loughmiller [[Filing No. 318](#)] along with Exhibit 1 [[Filing No. 318-1](#)], Exhibit 2 [[Filing No. 318-2](#)], Exhibit 3 [[Filing No. 318-3](#)], Exhibit 4 [[Filing No. 318-4](#)], Exhibit 5 [[Filing No. 318-5](#)], and Exhibit 6 [[Filing No. 318-6](#)] be maintained under seal in order to prevent the confidential information from being accessible to the public.

WHEREFORE, Receiver, by counsel, respectfully requests that the Court grant her Motion to Seal the original version of the Declaration of Jarit Loughmiller [[Filing No. 318](#)] along with Exhibit 1 [[Filing No. 318-1](#)], Exhibit 2 [[Filing No. 318-2](#)], Exhibit 3 [[Filing No. 318-3](#)], Exhibit 4 [[Filing No. 318-4](#)], Exhibit 5 [[Filing No. 318-5](#)], and Exhibit 6 [[Filing No. 318-6](#)] and for all other relief just and proper in the premises.
