Copeland of the law firm of Arnold Gallagher, P.C., Eugene, Oregon, and to employ Thomas M. Orr and Patrick L. Stevens of the law firm of Hutchinson, Cox, Coons, Orr & Sherlock, P.C., as special counsel for the Receiver in regard to the FarmGrowCap, LLC (“FarmGrowCap”) Oregon loans;

WHEREAS the Court finds that employment of special counsel for the Receiver in regard to the FarmGrowCap, LLC (“FarmGrowCap”) Oregon loans is reasonable;


WHEREAS, the Court finds that the invoice of Bradley S. Copeland is reasonable in light of the preliminary work he performed for the Receiver; and

WHEREAS Thomas M. Orr and Patrick L. Stevens of the law firm of Hutchinson, Cox, Coons, Orr & Sherlock, P.C., Eugene, Oregon have the knowledge and experience to appropriately assist the Receiver with those issues.

IT IS THEREFORE ORDERED THAT:

The Receiver is authorized to pay the invoice of Bradley S. Copeland in the amount of \$1,764.00 for the preliminary work performed by him on behalf of the Receiver and to retain Thomas M. Orr and Patrick L. Stevens of the law firm of Hutchinson, Cox, Coons, Orr & Sherlock, P.C., Eugene, Oregon, as special counsel for the Receiver in regard to the FarmGrowCap, LLC (“FarmGrowCap”) Oregon loans. The Court specifically approves the fees for said counsel at the rates set forth in Exhibit C to said motion and finds that the same are fair and reasonable and in the best interests of the Receivership entities.
