**RECEIVER’S MOTION FOR ENLARGEMENT OF TIME
TO FILE MOTION FOR RECEIVER’S NINTH QUARTERLY FEE APPLICATION**

William E. Wendling, Jr., the Receiver herein, by counsel, respectfully requests that the Court grant him an enlargement of time to and including August 25, 2017, in which to file his Motion for Receiver’s Ninth Quarterly Fee Application. In support thereof the Receiver states:

1. On May 1, 2015, the Agreed Order Appointing Receiver (“Agreed Order”) was entered appointing William E. Wendling, Jr., to serve without bonds as the Receiver over Veros Farm Loan Holdings LLC (“VFLH”), FarmGrowCap LLC (“FarmGrowCap”), PinCap LLC

(“PinCap”), and all private offerings in which Defendant Veros Partners controls investor funds (“Private Offerings”) [[Filing No. 34](#)].

2. Pursuant to the Agreed Order Appointing Receiver, within forty-five (45) days after the end of each calendar quarter, the Receiver and Retained Personnel are to file with the Court an application for compensation and expense reimbursement [[Filing No. 34](#), at ECF p. 21]. Receiver’s Motion for Ninth Quarterly Fee Application is currently due on August 15, 2017.

3. Receiver has been out of the office and has been occupied with other matters, to include the filing of the most recent motion to distribute funds to the private placement investors along with a yet to be filed motion and needs additional time in which to complete the Ninth Quarterly Fee Application.

4. On August 14, 2017, counsel for the Receiver contacted counsel for the United States Securities and Exchange Commission regarding this motion. On August 16, 2017, the SEC indicated they have no objection thereto.
