MOTION FOR EXTENSION OF TIME WITHIN WHICH TO SERVE ACCOUNTING

Defendants Veros Partners, Inc., Matthew D. Haab, and Veros Farm Loan Holding LLC, by counsel, J. Richard Kiefer, hereby moves the Court for a one-week extension of time within which to file their respective accountings as required by the Preliminary Injunction Order, and state the following in support thereof:

1. The Preliminary Injunction Order [Dkt. 48] issued on May 7, 2015 required that the defendants each submit in writing and serve upon the Commission an accounting within fourteen (14) business days following service of the Order. See Preliminary Injunction Order, IV at page 7. The accounting required by that Order is due on Thursday, May 28, 2015.

2. The undersigned counsel is working with his clients to prepare the accountings required by the Order but an additional week is needed to complete that process. The Order requires detailed accounting information from 2012 through 2014 and it has taken the

undersigned counsel and his clients considerable time to search for and obtain all of the records necessary to comply with the various requirements of the Order.

3. The undersigned counsel has contacted both Rob Moyer of the SEC and Bill Wendling, the Receiver appointed by the Court, to advise them of this request and determine if they object and they both have authorized the undersigned counsel to represent to this Court that they have no objection.

WHEREFORE, defendants Veros Partners, Inc., Matthew D. Haab, and Veros Farm Loan Holding LLC, pray that the Court grant a one-week extension of time to and including June 3, 2015 within which to submit their written accounting to the SEC.
